4) The discount is granted only if the package of products is ordered for internal use (only for client's own needs and within the company specified in the order).

5) The product covers data from the last Fixing and is available after the trading session (WIRON and POLSTR rates) and the next Business Day before 11:00 am CET (WIBOR and WIBID rates)
