

Resolution No. 506/2026  
of the Warsaw Stock Exchange Management Board  
dated 1 April 2026

concerning the introduction to exchange trading in the WSE Main Market  
of ETNs issued by  
VIRTUNE AB (PUBL)

§ 1

1. Pursuant to § 36, § 37 and § 38.1 and § 38.3 of the WSE Rules, the WSE Management Board resolves to introduce as of 8 April 2026 to exchange trading in the main market ETNs issued by VIRTUNE AB (PUBL), in 1 series of ETNs referred to in the Exhibit to this Resolution, in a number no higher than number of ETNs of a given series indicated in this Exhibit in the column "Issue Volume", registered by the National Depository for Securities under the code as indicated in the Exhibit to this Resolution;
2. Pursuant to § 2.1 of Division IV of the Detailed Exchange Trading Rules, the WSE Management Board resolves to list ETNs, mentioned in point 1., in the continuous trading system under the abbreviated name as indicated in the Exhibit to this Resolution.
